

## Elemental Balance in Greece

SEPTEMBER 20-27, 2024

### Registration Agreement

**I wish to register for Elemental Balance in Greece, September 20-27, 2024. I understand that Melanie Carroll Psaltakis, LLC (the "Company") and Sharon Neubauer (Opus Yoga), require that this Registration Agreement (the "Agreement") be signed as it must rely upon my registration in securing travel arrangements.**

**What's Included:** A small group of up to 15 yoga-travelers (the "Participant"); morning and evening yoga practices per itinerary; accommodations each night of the Trip, all meals per itinerary, all tours and activities with professional guide per itinerary, all transportation for included activities, and transfers at beginning of the Trip for designated airport. The itinerary provides free time for reflection and connection.

**What's Not Included:** Airfare to and from designated airport, optional tours, activities, travel, and meals taken independently, passport and visa fees, and travel and medical insurance. *Assistance with booking air travel can be provided by Wayfinders Travel, a division of Melanie Carroll Psaltakis, LLC.*

**Physical Demands:** A yoga practice of at least 6-12 months is recommended. Participants are expected to carry own luggage. Some sightseeing/activities on the Trip may require a moderate level of fitness and/or be physically challenging. Participants must be in sufficient good health and proper physical condition to take part in the Trip. If a Participant believes that any activity is or may be unsafe for them, they must immediately discontinue participation. Participant acknowledges that the Company has made no representation or warranty as to the suitability of the Trip for Participant or as to content of information provided by third parties. **Arrangements:** The Company reserves the right at any time to change or delay departure and return date or times due to weather, mechanical or any other reason in the Company's sole and absolute discretion and without liability therefor.

**Payment:** A deposit of \$750.00 reserves your spot for the Trip. Final payment is due at least 90 days prior to the start of the Trip. This date will be included on your deposit confirmation receipt. Credit card, Venmo ([@Melanie-Psaltakis](#)) and personal checks (payable to Wayfinders Travel) are accepted. If you sign up for a Trip less than 90 days before the Trip, the entire cost is due at time of registration.

**Cancellations and Refunds:** Trip deposit is refundable for 30 days from the date it is received, minus a \$75.00 administrative fee. After 30 days, the deposit is completely non-refundable. A deposit made 90-120 days before the Trip begins becomes non-refundable on the final payment due date. All payments become non-refundable on the final payment due date. If you book the Trip less than 90 days before its start date, the entire trip cost becomes non-refundable after 7 days. Refund requests must be in writing. If the Company cancels the Trip, then the entire amount you paid will be refunded to you within 30 days after the Trip is cancelled. If the Company cancels the Trip, the Company has no obligation to Participant for any additional costs such as for trip insurance, airline tickets, and additional optional travel expenses. *Purchasing travel insurance is strongly recommended.*

**Travel and Medical Insurance:** The Company recommends that you cover your trip investment with a plan that provides protection for trip cancellation, trip interruption, accident and sickness medical coverage, and baggage delays and loss. Participant understands that their current medical insurance may not provide coverage outside the United States. A travel insurance quote will be provided to Participant upon receipt of their Trip deposit. Please initial one.

\_\_\_\_\_ I intend to decline the trip insurance purchase, and thus assume all personal and financial responsibility for such expenses and arrangements that may arise before or during my trip.

**Photo/Audio/Video Participation:** The Company may photograph or otherwise capture and record Participant’s voice and physical appearance (the “Image”) for use in connection with the Trip and in the advertising, marketing and/or promotion of future Trips. The Company shall own the copyright and other rights in and to the Image. Participant releases any rights to the creation, production or distribution of the Image which may be included with other images. Please initial one.

\_\_\_\_\_ I do not consent to photo/audio/video participation, and thus assume all responsibility to remove myself from all group activity photographs and videos.

**Release:** Participant releases the Company, its officers, employees, agents, servants, independent contractors, vendors, suppliers, Melanie Psaltakis, and Sharon Neubauer of any liability for losses, costs, damages, consequential or punitive, or liability whether incurred by Participant or otherwise including but not limited to those arising from any form of negligence, personal injury or criminal activity.

**Indemnification:** Participant indemnifies, defends and holds the Company its officers, employees, agents, servants or independent contractors harmless, from and against all liability in connection with or arising from their participation in the Trip.

**Miscellaneous:** Participant acknowledges and agrees that this Agreement is made in the State of Maryland and shall be governed by Maryland law without respect to its choice of law provisions. Any party bringing a legal action or proceedings against any other party arising out of relating to this Agreement may bring the legal action or proceeding in the state or federal courts having jurisdiction over Montgomery County, Maryland. In the event that this Agreement must be enforced, the Participant shall pay the reasonable legal fees and costs of the Company. This Agreement constitutes the full, entire, and integrated Agreement between the Participant and the Company with respect to the subject matter hereof and supersedes all prior negotiations, correspondence, understandings and agreements among the parties hereto respecting the subject matter hereof, whether in writing or oral. All subsequent changes and modifications, to be valid, shall be by written instruments executed by the Company.
